### Subject: MINUTES OF 14<sup>TH</sup> CDA BOARD MEETING FOR THE YEAR 2020.

The 14<sup>th</sup> CDA Board meeting for the year 2020 was held on **September 18, 2020 (Friday) at 01:00 P.M**, in the Conference Room of Executive Block, CDA Headquarter, Islamabad under the Chairmanship of Chairman, CDA.

Chief Commissioner, ICT in addition to the assignment of Chairman, CDA attended the meeting, while Member Finance / Member Admin, Member Estate, DDG (HRD), Member Planning & Design and Member Engineering were present in the meeting. Director HS, DFA-I and General Secretary (CBA), CDA Union were also attended the meeting.
  - 4. Meeting commenced with the recitation of "Holy Quran" by Syed Safdar Ali, Secretary CDA Board. Thereafter agenda items were taken up for discussion and following decisions were made:-

# 14.1 <u>ISSUES REGARDING REGULARIZATION OF DAILY WAGES/ CONTRACT/ DPL EMPLOYEES. / REGULARIZATION OF DAILY WAGES AND CONTRACT EMPLOYEES.</u> EMPLOYEES.

#### **DECISION**

The summary was presented by DDG (HRD) and Member (Admin), CDA and briefed the Board that in Writ Petition No. 4604/2018 titled "Muhammad Ziaraf etc. Vs Capital Development Authority, etc", the Islamabad High Court, Islamabad directed vide Order Sheet, dated 26-8-2020 which is as under

#### "C.M. No.2312/2020.

"This is an application for placing additional documents on record. For the reasons stated therein, same is allowed subject to all just and legal exceptions. The status of the documents will be considered at the time of final arguments".

#### C.M. No.2313/2020

After hearing the parties at length, it appears that respondent CDA has taken particular stance in para 3 of its comments that ICAs No.151, 152, 153, 154, 155,156 & 194 of 2018, along with connected writ petitions No.2449/2017 and 3525/2017 were disposed of by the Honorable Division Bench of this Court vide order dated 16.5.2018 after recording of conceding statement of Member Admin, CDA Nadeem Akbar Malik. The CDA in the wake of the said judgment also placed heavy reliance on the regularization policy dated17.10.2017 notified by the Government of Pakistan, adopted by the CDA Board in their meeting. I have gone through the said notification adopted by the CDA Board which reveals that there are certain discrepancies as some points which were referred in the said policy are contrary to the CDA Ordinance, 1960 as well as CDA Employees Service Regulations 1992. Even para 2 of the CDA Board decision compels the authority to make an amendment in the CDA Employees Service Regulations 1992. When confronted learned counsel for CDA contends that the said amendment has not yet been given effect which is an administrative matter. However, defects highlighted by learned counsel for Petitioner today have to be considered by the CDA Board who is the competent authority to rectify those mistakes and resolve the issue of the employees of CDA.

ii. Be that as it may, Secretary Board after the approval of Chairman CDA shall place the matter before the Board in consultation with law department as well as learned counsel for CDA including Member Administration and HRD for resolution of controversy in order to rectify the mistakes in the matter.

iii. Learned counsel for CDA has conceded that as of today no fresh recruitment is in process and even nothing has been advertised by the CDA, however, True Copy if any such advertisement is published it will be submitted before this Court for perusal.

iv. The Secretary Board, CDA and Member Administration, CDA shall appear in person to apprise this Court regarding the status of the Board meeting to resolve the issue of Regularization Employees / Petitioners".

It was further elaborated that CDA entered into settlement with CBA after CDA Board decision dated 30.09.2011 and the daily wages / contract employees in BS-01 to BS-15 were regularized subject to availability of post and fulfillment of requisite qualification. The said notification was issued on 12.12.2012 where after thousand employees were regularized. The settlement is still in field. Accordingly Mr. Ammanullah Khan, General Secretary, CBA (Employees Union) was summoned to elaborate his point of view before CDA Board on the instant issue. He explained his point of view to the Board and further emphasized that If any person engaged after the cut of date (i.e.21.06.2018) will not any right or claim of regularization.

It was further highlighted that CDA Being autonomous body has its own regulation for appointment. Employees of CDA are not civil servant. Therefore clause –II of the policy 17-10-2017 is in contradiction to service Regulation, 1992 and it required to be reviewed by CDA board for appointment and regularization of 16 and above.

After due deliberation, CDA Board observed that the policy dated 17.02.2017 adopted by the CDA is contradicting with the CDA existing rules / regulations. The judgment passed in ICA No. 340/2017 does not speak for an automatic system process of regularization. The honorable Islamabad high Court while issuing comprehensive guidelines directed all statutory organizations / companies controlled by the Federal Government to decide the cases in accordance with their own service rules and a one time exercise for regularization of service of temporary employees.

Board principally agreed to the one time exercise for regularization of the service and further decided that service of all such employees, who are presently working on daily wages or DPL (Muster Roll) or contract basis, having two years continuous service (excluding project employees) would be considered for regularization in the following manner / procedure.

- a) The recommendation for regularization would be made through respective Departmental Recruitment Committee constituted under the CDA Employees Service Regulations, 1992.
- b) Fulfillment of requisite qualification, experience or initial appointments criteria as laid down in the CDA Employees Service Regulations, 1992 for the post against which employees are required to be regularized.
- c) Regularization would also be made against the availability of regular sanctioned post.
- d) Age relaxation shall be granted by deducting the period actually served as Daily paid / Daily Wages / contract basis by the employee.
- e) Any disturbance in regional quota while regularizing will be adjusted in future recruitment.
- f) Concerned Director shall verify the credential / academic / Educational documents, domiciles, appointment letter / first engagement letter, or any proof of employment all extension letters and Provision of certificate that employee have two years continuous service at his credited, duly verified through Paid Voucher of each employee by the concerned DDO/ Deputy Director that the said employees in CDA pay roll up to 21.06.2018.
- g) The recommendations of DRC will be submitted to relevant competent authority for approval.

The summary was presented by DFA-I and who briefed the Board that CDA Board approved the proposed budget estimates for fiscal year 2020-21 in 7th Board meeting held on 17/06/2020. The same was forwarded to Ministry of Interior vide letter No.CDA/FW(B)-42(27)A/2020-21/149 dated 19/06/2020 for its approval. Deputy Secretary (CDA), Ministry of Interior vide letter dated 07/07/2020 conveyed the directions of MOI that CDA's Board may revise summary for MCI FY 2020-21 for two quarters instead of one quarter. CDA Board revised budget estimates for FY 2020-21 with 02 quarters provision for MCI out of CDA Budget on loan basis and forwarded to MOI vide Finance Wing letter No.CDA/FW(B)-42(27)A/2020-21/160 dated 13/07/2020.

Now, MOI referred letter again with the directions that the required budget estimates, mentioned for FY 2020-21, for MCI may be revised to two quarters (1" Half of FY 2020-21) instead of one quarter as the 2<sup>nd</sup> quarter for FY 2020-21 is going to start from 19 October 2020.

After due deliberations as well as observations, Board approved the proposal contained at Para 4 of the summary, and amounting to Rs.16. billion had already been allocated to MCI on loan basis which observed that funds may be returned back to CDA. Federal Government will compensate the CDA through MOI, because the performance of CDA could not be compromised.
