2<sup>nd</sup> CDA Board meeting for the year 2020 was held on **March 20, 2020** (Friday) at 10:00 A.M, in the Conference Room of Executive Block, CDA Headquarter, Islamabad under the Chairmanship of Chairman, CDA.

3. Commissioner Rawalpindi as ex-officio member of the Board could not attend the meeting, while Chief Commissioner, ICT in addition to the assignment of Chairman, CDA and Board Members attended the meeting.

#### <u>11124/1359/BM/'20</u> 2.1 <u>TEMPORARY DUMPING SITE FOR SOLID WASTE.</u> <u>20-03-'20/2<sup>nd</sup></u>

#### **DECISION**

The summary was presented by Member (P&D), CDA. After due deliberation, the CDA Board approved the proposals contained in Para 5 of the summary for using the designated site for temporary dumping of municipal solid waste and transfer station.

### <u>11125/1359/BM/'20</u> **2.2** <u>**RE-PLANNING OF PLOTS FOR WIDOWS OF CDA EMPLOYEES.**</u>

#### **DECISION**

## 11126/1359/BM/'202.3REQUEST FOR CHANGE IN THE LAND USE OF MAUVE AREA,<br/>SECTORS G-13 & G-14/4, ISLAMABAD.

#### **DECISION**

The summary was presented by Member (P&D), CDA. The Board was informed that in pursuance to the Federal Cabinet on summary moved by Ministry of Housing & Works regarding **"Change in land use of Mauve Area of Sector G-13 & G-14 Islamabad"**, had decided vide decession No.374/15/2019 dated 09.04.2019 that the matter regarding the change in land use be taken up by CDA Board. Subsequently, CDA Board in its meeting held on 16.04.2019 decided that

The Federal Cabinet being the final authority with regards to any changes in the Master Plan of Islamabad, and or amendments thereof has already decided the matter. The CDA Board realizing the forthcoming inauguration by the Prime Minster of Pakistan scheduled on 17 April, 2019 for social housing scheme has primarily endorsed the decision of the Cabinet with regards to the 7 acres for which title already vests with FGEHF. Since land in question is directly acquired by FGHEF therefore, no compensation is payable to CDA. The said 7 – Acres of land will be used for residential scheme as envisaged above. As regards the rest of request regarding entire Mauve Area for usage other than the purposes of the Naya Pakistan Housing program, the DG was advised to place a detail Proposal through Ministry of Housing for consideration by CDA Board separately."

The Deputy Secretary (Estate), Ministry of Housing & Works forwarded proposed Layout Plan of Mauve Area Sector G-13 and G14/4, Islamabad and requested for processing the same in the light of Cabinet Decision, to complete Prime Minister's Revenue Generated Project in Mauve Area G-13 & G-14 vide letter No. 1(5)/2019-HA/Planning dated 03.01.2020, which was forwarded by Section officer CDA-II, MOI vide letter No. F.52-8/2019/CDA-II dated 07.01.2020. After due deliberation, the CDA Board decided that since the change in land use require change in Master Plan, the matter may be referred to the Federal Cabinet. (being the Competent Authority in this regard) through Ministry of Interior.
