10.1 CREATION OF BUILIDNG CONTROL DIRECTORATE –III IN CDA.

DECISION

The summary was presented by Member (P&D), CDA. After due deliberation, Board agreed with the proposal creation of Building Control Directorate-III by re-designating / re-naming the current Architecture Directorate-III as Building Control Directorate-III. The annexed organization structure available in presentation to Prime Minster for BC-II,III and BC-I was also approved. Similarly, Board principally approved the establishment of Directorate of Urban Infrastructure Development for liaison with relevant directorates of Metropolitan Corporation Islamabad. It will be responsible for operation and maintenance of Park Enclave, Parking Plazas and remodeling / clearing of nullahs. Roads Division-I will be converted to Urban Infrastructure Development Division and will work under Roads Dte. South until the Director of UID becomes functional.

However, Board examined that further work distribution would be made by the member concern with the approval of Chairman, CDA. Vacant position will be filled through internal arrangements.

APPLICATION PERTAINING TO PLOT NO. 01, BLUE AREA (F-8) IN CONTEXT OF BUILDING REGULATIONS 2020

DECISION

The summary was presented by Member (P&D), CDA. After due deliberation, Board observed that commercialization of basement has to be examined in accordance with the rules and regulations. However, additional FAR as allowable under the building regulations and in pursuance to the concession announced by the federal government and Prime Minster regarding high rise as well as construction activities utilization of requisite space can be committed under the conditions and restrictions indicated by the planning wing. Necessary payment will have to be deposited, which will be worked out subsequently and there will be no impact under requirement indicated for parking, moreover additional requirement for parking which may arise on basis of permission will also be changed by the developer.

After due deliberation, the Board decided that the owner of the plot would either mortgage 10% of the saleable area in accordance with the approved plan OR provide Five percent insurance guarantee of the project value with sky structure and land cost from AA rating insurance company OR 5% bank guarantee in favour of CDA. The same will be released after the successful completion of the project as per Byelaws. The relevant clause of Building Regulations 2020 be amended and accordingly notified in the Gazette through PCP, after completing of codal formalities and duly vetted from Law Wing.
