 - 4. Meeting commenced with the recitation of "Holy Quran" by Syed Safdar Ali, Secretary CDA Board. Thereafter agenda items were taken up for discussion and following decisions were made:-

16.1 ENHANCEMENT OF STIPENDS FOR UNDER TRAINING POST GRADUATE $\frac{11241/1373/BM/'20}{09-10-'20/16^{th}}$ RESIDENTS AND HOUSE OFFICERS.

DECISION

The summary was presented by Member (Admin), CDA. After due deliberation, Board approved the proposal made at Para 3 and 4 of the summary, regarding adoption of orders of Prime Minister of Pakistan for enhancement of monthly stipend for under training Post-graduate and House Officers with immediate effect as circulated by the Ministry of Nation Health Services Regulation & Coordination, Government of Pakistan vide letter F.No/9-24/2016-E-1 dated 27-01-2020. Adoption would also be incorporated in the CDA Employees Regulation, 1992, accordingly.

16.2 <u>CHANGE OF NOMENCLATURE OF THE POST OF CARDIOLOGIST (BS-19) AS</u> 11242/1373/BM/'20PHYSICIAN (BS-19).

DECISION

The summary was presented by Member (Admin), CDA. After due deliberation, Board approved proposal at Para-08, however, it was observed that there is dearth of qualified doctors in Capital Hospital as compared to its previous history. A detailed study for inclusive hierarchy of the missing posts and establishment of new departments, such as infectious disease and cardiology etc as well as better career planning of the existing Doctor / Specialists is required for the Capital Hospital. Board further directed that a committee would be constituted under the supervision of Member Finance comprising the officers DG Management, DG HRD and Executive Director Capital Hospital to conduct detailed study within a period of one month. The committee will submit its report along with a comprehensive summary focusing the all aspects, requirements to the CDA Board.

DECISION

The summary was presented by Member (Admin), CDA. After due deliberation, Board principally agreed with the proposal made at Para 6 of the summary for provision of Risk Allowance to healthcare employees of DHS and CARES-1122 directorates of MCI on account of Corona Pandemic. However, the proposed implication and incidence needs to be re-scrutinized on the basis of duty actually performed, so that transparency can be ensured. The allocation should not be arbitrary rather should be evidence based. So that only those employees are considered who were actually exposed to the risk.

The ownership of Temporary Kiosk/ Khokha Sites will remain with the CDA and these Kiosk/ Khokha /Sites are non-transferable. Board further directed that as per existing rule and regulation of DMA kiosk / Khokha policy, the Directorate of Municipal Administration, MCI would forward the each case for earmarking of site for Temporary Kiosk/ Khokha to Planning Wing, CDA on case to case basis. After considering and examining the each case, the Planning Wing, CDA, would earmark Temporary Kiosk/ Khokha / Sites, in accordance with planning parameter and existing rule and regulation.
