#### Subject: MINUTES OF 3<sup>RD</sup>CDA BOARD MEETING FOR THE YEAR 2021.

The 3<sup>rd</sup>CDA Board meeting for the year 2021 was held on **February 16, 2021** (**Tuesday**) at 09:30 A.M in the Conference Room of Executive Block, CDA Headquarter, Islamabad under the Chairmanship of Chairman, CDA.

- 2. Following attended the meeting:

  - 4. Muhammad Ayaz Khan Member (Engg.), CDA (Day to day work relating to Member Engg. Office)
  - 5. Syed Safdar Ali, Secretary CDA Board.

3. Commissioner Rawalpindi as ex-officio member of the Board could not attend the meeting. Chief Commissioner, ICT in addition to the assignment of Chairman, CDA attended the meeting, while Member Finance, DG (Management), Member Estate, Member Planning & Designand Member Engineering were present in the meeting.

4. Meeting commenced with the recitation of "Holy Quran" by Syed Safdar Ali, Secretary CDA Board. Thereafter agenda items were taken up for discussion and following decisions were made:-

# 3.1REVISION OF CDA POLICY FOR GRANT OF HOUSE BUILDING ADVANCE ,<br/>MOTOR CAR ADVANCE, MOTOR CYCLE/ BICYCLE ADVANCE IN THE LIGHT<br/>OF FEDERAL GOVERNMENT'S POLICY ON THE SUBJECT.

#### DECISION

The summary was presented by DG (Management) CDA. After due deliberation and on the basis of information / inputs of the summary, the board decided to revalidate the already adopted Federal Government policy and approved the proposal made at Para 6 of the summary subject to the following modification /amendment / alteration in the revised policy clausesVII, VIII, X, XIII, XIV, XVIII of sub Para D:-

- **a.** Date & period for receiving applications shall be notified by the concerned HDR Directorate with the approval of Member (Admin) / D.G (Management).
- **b.** All applications on prescribed format must be received or submitted in the office of Member Admin / DG Management on or before the cut-off date as notified by the HRD. No application would be entertained without the Dairy Number of the office of Member Admin / DG Management. Proper / verifiable record of applications received shall be maintained in the said office.
- **c.** For application received for 1<sup>st</sup> Advance of House Building, Motor Car and Motor Cycle, the seniority of the applicant will be determined amongst applicants according to their date of appointment. While Application received for 2<sup>nd</sup>and 3<sup>rd</sup>Advance of House Building, Motor Car and Motor Cycle, the seniority of the applicant will be determined amongst applicants according to date of their duly diarized application received in the office of Member Administration / DG Management
- **d.** Till the time applications for 3<sup>rd</sup> time HBA advance are received (because in prevailing policy no CDA employee has received 2<sup>nd</sup> time HBA as yet), the share of allocation for 3<sup>rd</sup> time applicants of HBA would be equally divided into 1<sup>st</sup> and 2<sup>nd</sup> and the ratio of allocation for 1<sup>st</sup> and 2<sup>nd</sup>advances will be 75%, 25% instead of 1<sup>st</sup>, 2<sup>nd</sup>& 3<sup>rd</sup> advances i.e 70%, 20% and 10% respectively. However, allocation for HBA shall be separately made for gazetted and non-gazetted officers/officials as per previous policy.
- **e.** The cases of officers/officials on deputation to CDA for grant of HBA, MCA etc. shall continue to be dealt with under the relevant Federal or Provincial Government's policy on the subject. Member (Admin) / DG (Management) shall be the authority to accord admin approval whereas financial approval shall be granted by F.A / Member.
- **f.** Yearly and intermittent (if so needed) budget allocation under the head of HBA/MCA/Bicycle advance etc. shall be made with the approval of the Chairman, CDA.

#### 3.2 <u>AMENDMENT IN "APPOINTMENT / PROMOTION CRITERIA" OF THE POST OF</u> <u>11305/1379/BM/21</u> <u>16-02-'21/3<sup>rd</sup></u> <u>HEAD NURSE (CARDIAC SURGERY) BPS-17, APPROVED IN PC-I FOR THE</u> <u>PROJECT REGARDING "ESTABLISHMENT OF CARDIAC DEPARTMENT AND</u> <u>PROCUREMENT OF CARDIAC SURGICAL EQUIPMENT AT CAPITAL</u> <u>HOSPITAL, ISLAMABAD".</u>

#### DECISION

The summary was presented by DG Management CDA. After due deliberation, the Board agreed with the proposal up to the extent that promotion quota for the post will be utilized first in accordance with Clause-4.19 of CDA Employees Service Regulation 1992 to remove the anomaly. However Board further directed that the Admin Wing may approach the Ministry of National Health Services Regulation & Coordination and other sister organizations in Federal and Provincial governments to obtain detailed input on

their existing service structure for the posts of Nurses, Head Nurses, Assistant Nursing Superintendent and Nursing Superintendent including Head Nurse Cardiac Surgery. Admin Wing would examine the policy and formulate a better service structure of nursing staff of the CDA Hospital at par with the Federal / Provincial health departments.
