#### Subject: MINUTES OF 1<sup>ST</sup> CDA BOARD MEETING FOR THE YEAR 2021.

The 1<sup>st</sup> CDA Board meeting for the year 2021 was held on **January 01, 2021** (Friday) at 03:30 P.M in the Conference Room of Executive Block, CDA Headquarter, Islamabad under the Chairmanship of Chairman, CDA.

- 2. Following attended the meeting:

  - 5. Muhammad Ayaz Khan Member (Engg.), CDA (Day to day work relating to M. Engg. Office)
  - 6. Syed Safdar Ali, Secretary CDA Board.

3. Commissioner Rawalpindi as ex-officio member of the Board could not attend the meeting. Chief Commissioner, ICT in addition to the assignment of Chairman, CDA attended the meeting, while Member Finance, DG (Management), Member Estate, Member Planning & Design and Member Engineering were present in the meeting.

4. Meeting commenced with the recitation of "Holy Quran" by Syed Safdar Ali, Secretary CDA Board. Thereafter agenda items were taken up for discussion and following decisions were made:-

#### 1.1 MECHANISM TO ENSURE MERIT BASED RECRUITMENT IN THE CDA.

#### 11287/1377/BM/'21 01-01-'21/1st DECISION

The summary was presented by DG (Management) CDA. After due deliberation and on the basis of information / inputs of the summary, the board approved the proposal made at Para 6 of the summary regarding procedure / mechanism to ensure merit based recruitment in the Authority.

However, during the meeting, board discussed various others and HR related issues and Board further approved that:

- a) Without the prior consent of Member concerned, No file / case would be forwarded to Law Wing for obtaining legal opinion.
- b) Clarification may be sought from the MOI regarding restriction of advertisement or obligation of NOC. In pursuance to the CDA Ordinance 1960, wherein, Government is defined as "Cabinet", if there is any restriction of the Government for advertisement of posts or obligation of NOC required. Otherwise, in the light of recent IHC decision as well as in accordance to the CDA Ordinance 1960, CDA is competent being Authority, having its own Board empowered to make regulations as per laid down procedure in the CDA Ordinance 1960 for the appointment of its officers, servants, experts and consultants, and the terms and conditions of their services in pursuance to the Sections 38, 50 & 51 of the ibid law.
- c) Planning wing may present a summary before the CDA Board in the next Board meeting for the creation of posts
  - i. 15 posts of Building Inspector (BS-16), 05 posts for each Building Control Directorate
  - ii. 05 posts of Land Surveyor (BS-16) for Building Control Directorate. However, vacant posts due to retirement of incumbents in Building Control Directorates would be filled first through initial appointment as per regulations.
- d) There are 04 sanctioned posts of Director Architect (BS-19) in Design Wing, Two posts will be intact as Director Architect (BS-19) on the strength of Design Wing, while One post of Director Architect (BS-19) will be transferred and renamed as Director Building Control –III for the Building Control Directorate III and One post of Director Architect (BS-19) will be abolished henceforth.
- e) Only essential and limited posts of Engineering Wing would be filled out of 119 posts, however, Member Engineering will give briefing to Chairman on the following:
  - i. What is the requirement of the posts?
  - ii. What are the justifications of the posts?
  - iii. Sufficient reasons be given for maintaining of existing posts.
  - iv. Reconcile the charges assigned to one incumbent; if one incumbent holds two or three charges, these posts, Division as well as Directorate should be merged, accordingly if possible.

- v. An O&M study of Engineering Wing is required to rationalize these posts.
- f) Process for filling the 218 vacant posts of various categories of Capital Hospital may be started without any further delay.
