Spl.2.1 AUCTION OF COMMERCIAL PLOTS-29,30 AND 31 MARCH, 2021.

Summary was presented by the Member (Estate), CDA, after due deliberation Board approved the followings:-

- a) Auction of Commercial plots would be held 29th, 30th and 31st March, 2021 at Jinnah Convention Center, Islamabad. However, residential Auction would be scheduled separately.
- b) Committee for the supervision of Auction of Commercial plots, as mentioned at Para 6 of the summary.
- c) Draft brochure for Auction of Commercial plots along with terms and conditions.
- d) List of plots, comprising of; plot number, Sector, Dimension & Size, Category and Token money. However, measurements / size of indicated plots in the summary be reconfirmed in consultation with Planning Wing. Moreover, it must be ensured that there is no litigation on the plots placed in the auction.
- e) With reference to Para 4 of the summary, the plot No. 1 of I-8 Markaz initially planned for hotel, it was decided to change the purpose of the plot to commercial and its division into two plots instead of three in order to provide enhanced parking facility and to fetch more revenue as hotel plot has already been auctioned in I-8 Markaz.
- f) Surroundings and location of all commercial plots presented for forthcoming auction be made clear from wild growth etc and Director EM –II to coordinate with Environment Directorates, MPO Directorate and Enforcement Directorate.
- g) Public Relation Directorate, to disseminate the information to general public, investors and overseas Pakistani, media campaign would be commenced well before the auction schedule.
