#### **DECISION**

It was apprised to the Board that CDA conceived its first ever Islamabad Bus Service (IBS) project and launching the phase-I of Islamabad Bus Service on the following two (02) routes Blue Line Service (from Korang Interchange to PIMS) and Green Line Service (from Bara Kahu to PIMS) to facilitate the general public, who are presently commuting to urban areas and utilizing expensive and inconvenient modes of transportation. After due deliberation and information / input of the summary, the Board approved the following.

- i) Operations of Islamabad Bus Service IBS will be managed by Islamabad Dev. Fund Limited (IDFL) the company owned by CDA till the Federal Government establishes a separate entity for public transportation in the capital city (Islamabad). The executive and development works relating to Islamabad Bus Service (IBS) will continue to be conducted by CDA.
- ii) Phase-I of the Islamabad Bus Service (IBS) Project would be undertaken on the following two (02) routes, **Blue Line Service** (from Korang Interchange to PIMS) and **Green Line Service** (from Bara Kahu to PIMS)
- iii) Blue Line & Green Line routes will be operated on a Kerb side arrangement.
- iv) Out of upcoming fleet of 30-buses procured for the Orange Line Metro Bus service, Eight (08) buses for Blue Line and Four (04) buses for Green Line would be allocated.
- v) Rest of Eighteen (18=15+03) buses will be utilized for the Orange Line Metro Bus service.
