4. In addition to the above, DG (HR), Legal Advisor, CDA, Director HRD-II, Director MBS and representative of M/S APCO attended the relevant agenda items of the meeting.

5. Meeting commenced with the recitation of "Holy Quran" by Syed Safdar Ali, Secretary CDA Board. Thereafter agenda items were taken up for discussion and following decisions were made:-

### 5.1 ARRANGEMENT BETWEEN PUNJAB METRO AUTHORITY AND CDA.

The subject agenda item could not be discussed, for want of coherent information.

### 5.2STANDARD POLICY/PLANNING PARAMETERS OF EXISTING/NEW PETROL11492/1394/BM/22PUMPS IN THE ROW OF ISLAMABAD HIGHWAY AND SRINAGAR HIGHWAY,25-04-'22/5<sup>th</sup>ISLAMABAD FOR CDA/PRIVATELY OWNED PETROL PUMPS.

### DECISION

The Summary was presented by Member (P&D). CDA Board in its 3rd meeting, had directed planning wing that the Board decision, dated 28-04-2020, needs to be reexamined in order to make a comprehensive policy. The Private Board Members observed that enhancing commercial usage to 70% would tantamount to conversion of land of petrol pump into a commercial construction project which would defeat the purpose. Moreover, petrol pump sites are not just the exclusive domain of CDA but are also dealt under the Petroleum Act, 1934 and by other departments such as Department of Explosives and Ministry of Petroleum. In this context the existing dispensation may be adhered to. Moreover, it should be ensured that even in CDA owned sites the same laws are applicable.

Furthermore, it was further observed that no rationale for requisite length of service for time scale promotion in various grades was given therein. After due examination of the matter, the HRD Wing has recommended the time scale promotion method and criteria with certain necessary amendments contained at Para 6 of the summary for adoption / decision by the CDA Board, keeping in view specific requirements in CDA.

After due deliberation and on the basis of information /inputs of the summary, the Board approved the proposal for introduction of time scale promotion method in principal in

CDA, however, the criteria for the employees working in BPS-01 to BPS-19 only regarding minimum length of service in each scale would be ten (10) years service for being eligible for time scale promotion to next scale/grade. The rest of the proposal at para-6 of the summary, with aforementioned modification, is approved by the board.

Moreover, grant of "Danger / Nuisance Allowance" @Rs. 1000/-may be approved for employees of City Sewerage Directorate as they perform similar job as compared to staff of Sanitation Directorate to whom said allowance is already admissible. Moreover, disparity in amount of nuisance allowance as admissible to Sanitation Directorate may be removed and eligible staff of both Directorates may be granted same amount, whichever is higher.

After due deliberation, the Board reviewed it earlier decision up to the extent of Security Allowance under caption Additional various allowances that Security Allowance @ Rs. 5000/ per month that would be extended to all security staff working in the authority. Moreover, the proposal w.r.t Danger and Nuisance allowance is also approved on the basis of information /inputs in this regard.
