1.6 REGULARIZATION OF THE SERVICE -CONSIDERATION OF THE 31437/1390/BM/'22 REPRESENTATIONS/APPEALS SUBMITTED BY DAILY WAGES/ CONTRACT/DPL 51437/1390/BM/'22 EMPLOYEES (WHOSE SERVICES WERE DISPENSED WITH).

#### **DECISION**

The summary was presented by the Director HRD-II, CDA. It was appraised to the board that in pursuance to the decision in its 5th Meeting held on 02-06-2021, a committee was constituted vide HRD Directorates letter No.CDA-7(01) HRD-III/2021/745 dated 08-07-2021 to review the cases of the aggrieved Daily wages, Muster Roll & DPL employees etc. of the Authority, whose services were dispensed with and to consider the representations/appeals of these aggrieved Daily wages, DPL employees etc. and to submit its report/ recommendations to the CDA Board for its final decision. The Committee examined the record provided by HRD and held its day to day proceedings by giving opportunity of personal hearings to each such individual. On the basis of examination of record and input received from the aggrieved persons during personal hearings, the committee concluded its proceedings and submitted two reports due to division of opinion amongst committee members. The two reports submitted by the committee has split mandate with reference to their findings and recommendations. The committee has not succeeded in arriving at clear & consolidated findings / recommendations regard applicability to Employees Service Regulations, 1992 read with Islamabad High Court decisions and previous Board decision on the subject. Moreover, committee has also varied opinion regarding the applicability of Islamabad High Court decision dated 23.08.2021 in W.P. No. 1918/2021 titled Muhammd Zubair Vs CDA etc.

After due deliberation and on the basis of information/inputs of the summary, board decided to constitute another committee comprising of DG (A&A) as Chairman and DG (Services), Director –I (HRD), Director –II (Law)as Members of the committee and Deputy Director –II (HRD) as member-cum-secretary. The terms of references for the new committee would be as under:

- a) The services of 400 daily wages, DPL and Muster role employees were regularized whereas, services of 141 daily wages, DPL and Muster role employees were dispensed with on the recommendations of respective DRSs by the CDA Board in pursuance of decision of Islamabad High Court in Writ Petition No. 4604/2018 titled "Muhammad Ziaraf etc, ICA No.155/2018 in WP.2045/2017 titled Bin yameen Masih, ICA No. 340/2017 dated 21-06-2018 read with CDA Board decision dated 13 & 19-09-2019 and 29-09-2020. In such circumstance, whether CDA Board itself is competent to entertain representations/appeals of terminated employees (contract, daily wages & muster role) and review its earlier decision on the basis of recommendations of the proposed committee, if so any?
- b) What are the legal repercussions of Islamabad High Court decision dated 23.08.2021 in W.P. No. 1918/2021 on the proceedings of new committee being constituted to reexamine the case and subsequent decision to be taken by the CDA Board?
- c) In case CDA board is competent to review its earlier decision as elaborated at (i) & (ii) above without any legal repercussions, the new committee shall proceed in the light of prevailing provisions of CDA Employees Service Regulations, 1992 read with all aforementioned decision of Islamabad High Court on the subject and previous board decisions to examine the representation of all 141 persons in question, to afford personal hearings to them (if so needed), recommend regularization of such persons against the posts against which they were working on daily wages, DPL or muster role basis (if any regular vacancy exist) or any equivalent post (if no regular vacancy exist) or to adhere to the earlier CDA Board decision dated 15.03.2021 (in toto or partially) regarding dispensing with their services.

It was also discussed that the Authority has to bear a considerable cost on account of unforeseen delays in handing over physical possession. The value of land and the cost borne by the Authority in development of land does not commensurate with the minimal charges being levied. After due deliberation and on the basis of information/inputs of the summary, the board approved the levy of possession charges in under developed/newly developed sectors at following rates:-

Therefore it requires a piece of land adjacent to the Sports Complex on Garden Avenue for said purpose.
