## **SUMMARY FOR CDA BOARD**

## Subject:-UNIFORM PLANNING PARAMETERS FOR CONSTRUCTION OF MEDIUM RISE RESIDENTIAL APARTMENTS IN ZONE-II, ZONE-IV AND ZONE-V

The CDA Board during the 6th Board Meeting held on May 09, 2018 has approved following planning parameters for the construction of Medium Rise Residential Apartments in Zone-II, IV and V. The details are uploaded on CDA official website for the information and comments of all stakeholders within the period of two weeks of publishing of this document:

Where Sewerage network is not available, provision of a compact Sewage Treatment Plant for disposal of sewage shall be made or fully sealed septic tanks, which shall be mechanically drained through flushing unit, be provided.
Solid Waste Management System	Solid Waste Management plan to cater for the disposal of garbage generated from the premises @ of 1kg/person/day shall be submitted along with the plans for approval. Garbage shall be transported to the approved disposal sites.
Completion period	For 20 kanal-100 kanal 3 years For 101 kanal -150 kanal 4 years For 151 kanal -200 kanal 5 years
Bank guarantee	@Rs300/- per square feet of covered area of the project which will be released on the completion
