Director (Production-I), CDA being cost of the Bidding Documents. No application will be received / entertained without tender fee and after above mentioned date & time.
- 3. Project related information may be sought from the office of Dy. Director Production-I located at Room No.166, First Floor, Old Naval Headquarter, Melody Sector G-6, Islamabad.
- Only firms/contractors registered with PPRA on E-PADS as vendors are eligible to purchase bidding documents.
- Tender should be accompanied Bid Security /Earnest Money (refundable) in the form of Pay order/CDRs in favor of Dy. Director (Production-I), CDA. The prospective bidders shall upload scanned copy of Bid Security on
 - E-PADS well before opening date & time and original will be submitted to the office of Director Water Supply, CDA for the work mentioned above along with the bid.
- 6. In case the total bid amount is less than 10% below the NIT amount, the bidder shall submit call deposit as performance security equal to the difference between NIT amount and total quoted amount less 10% of NIT amount. That is required performance security = NIT amount total bid amount 10% of NIT amount. This call deposit shall be in addition to the earnest money for the work and shall be deposited at the time of submission of bids. Bids not carrying the performance security shall be rejected. The performance security of the successful bidder shall be released after completion of the project.
- 8. The prospective bidders are also required to submit their Bids online through E-PADS at http://eprocure.gov.pk before opening date. Original bids in accordance with the provisions of Rule 36 (a) of Public Procurement Rules-2004 and terms & conditions defined in the bidding documents must be submitted for the work in the office of Director Water Supply Room No. 16 located at Ground floor Old Navel Headquarter Melody G-6 Markaz, Islamabad on or before 12.08.2024 at 11:30 AM.
- 9. The Bids will be opened publicly on **12.08.2024** (Monday) at **12:00 PM** in the presence of the procurement committee & Bidders' authorized Representatives who choose to attend the opening session to be held at above mentioned address in the office of Director Water Supply, CDA, Islamabad.
- 10. The Firm providing unsubstantiated and / or incorrect information is liable to legal action and disqualification from the bidding.
